### **Course Objectives:**

This course aims to provide students with a comprehensive understanding of the financial environments in Asia. It first introduces the important principles of finance, banking and insurance, and then delves into specific markets to discuss their institutional, cultural and financial characteristics. Recent events such as the Asian Currency Crisis and China joining the WTO are also discussed.

The course should appeal to students with a non-finance background (or doing a non-finance-related degree) who are interested in expand their future career into the financial world, or who plan to work in the Asia-Pacific region, or who simply want to enrich their expertise with a broad understanding of international financial markets

# **Reading Materials:**

Due to the dverse nature of this course, there is no prescribed textbook. In each lecture, I will distribute handouts, which will be required reading materials for the next lecture.

In addition, I will be regularly updating the subject web site (WEBCT) with the most recent lecture notes and other relevant course material so check the course web site often. Together with lecture handouts, these notes are examinable.

#### **Attendance:**

Regular class attendance of all students is expected and class participation/discussion will be marked.

## **Grading Components:**

The grading components of the course are divided into four forms: class participation/discussion, quizzes, assignments and presentations:

• Class participation/discussion: 5%

• Mid-session quiz: 20%

• Assignment: Report 20%, Peer review: 5%

• Presentation: Own presentation: 15%, Peer review: 5%

• Final quiz: 30%

## Participation/Discussion

This is individual (i.e. non-group) assessment. Marks are awarded according to each student's in-class activities, such as the ability to answer questions raised and critically discuss relevant issues.

### **Quizzes**

There are two quizzes given in this course: mid and final quizzes (both are administered in class). Both are individual assessments. The mid session constitutes 20% of your course grade and will be composed of multiple-choice and true/false questions. The final constitutes 30% of your course grade and will be in the form of written short and essay-type questions.

# **Assignment and Presentation**

The assignment and presentation are both group assessments. They will be on one topic selected from those distributed in Week 2 of lectures. Both should follow a professional style of presentation. Each group should have 3 members only.

The assignment is due in Week 9 in class. Two copies of the assignment report could be handed in. One will be marked by me; the other will be reviewed by a peer group.

The presentation component of this course constitutes 15% of your grade and will be conducted in class. Materials presented with also be reviewed/rebutted by myself as well as your peers. The presentation is considered to be an extremely important part of your experience. It is expected that the presentation will reflect your ability to integrate and synthesize the course content into a professional analysis.

### **Peer Review**

Each group will be required to write a two-page review of another group's assignment report. This review should outline the report's topics, key findings as well as its strengths and weaknesses. Members of the reviewing group will also serve in a critique panel of the reviewed group's presentation to discuss/evaluate/question the contents of the presentation.

## **Grade Appeals**

Requests for consideration of review of graded items will only be accepted for a period of one week (seven days) after the return of that graded item to the student for his/her review. These re-grade requests **must be submitted in written form** (preferably via email) identifying the specific issue under question and provide a rationale as to why the student believes the issue under review is deserving of additional points.

# **Special Consideration:**

Any requests for "special consideration" must *strictly* follow official UNSW guidelines, which can be found in <a href="http://www.student.unsw.edu.au/studentguide/assess.htm">http://www.student.unsw.edu.au/studentguide/assess.htm</a> It is the *student's* responsibility to understand the process for filing such requests. Additionally, the student must notify the instructor

prior to an examinable event to explain their situation and their intentions to file such requests. Failure to do so will automatically result in the rejection of any special consideration request. A student requesting special consideration is generally eligible for only a passing mark.

### **Student Misconduct:**

Students in this course are expected to be familiar with the standards of acceptable academic behavior at the UNSW.
